heelock's 2024 Town Meeting will present voters with many important issues to consider, as well as, positions to fill that are vacant either through term limits or resignations. The summer (and winter) floods caused considerable road damage, and with more extreme weather events likely in the future, the resources for road maintenance and repair are likely to generate a lot of discussion. Residents will be considering *"total highway fund expenditures of \$464,356 of which \$360,216 shall be raised by taxes \$104,140 by non-tax revenue"* ... and the *"purchase of a new dump truck to replace the '09 International, in an amount not to exceed \$240,262.00, less the trade in of \$25,000"*.

As noted in the **Selectboard Report**, the town is still required to ensure the Town Hall complies with the **ADA** (Americans with Disabilities Act). In 2023, however, after earmarking ARPA funds for it in 2022, then drawing up architectural plans, drafting grant applications, and holding public meetings, the Selectboard withdrew the grant applications and "no other plans have been formalized to date". Town Meeting attendees who are unable to negotiate the stairs to the lower level bathrooms, are "accommodated" with an outdoor porta-potty.

The Town Meeting Warning includes a new appropriation request to cover Wheelock residents' admissions to the Fairbanks Museum. The recently completed **Tang Science Annex** offers interactive science stations for all ages and a "construction zone" play area with Legos, Wix, blocks, etc., for children to enjoy. <u>https://fairbanksmuseum.org/</u>





#### Town of Wheelock : Vermont's Gift to Dartmouth College

# ARPA Status (The American Rescue Plan Act)

Ongress passed ARPA in 2021 committing \$1.9 trillion to address the economic effects of the COVID-19 pandemic, including monies to invest in infrastructure and assistance for economically disadvantaged communities. The State of Vermont received about \$2.7 billion and dedicated a large portion to a variety of statewide projects, as well as to individual municipalities—**Wheelock** received \$246,971.12. The funds must be <u>obligated</u> by **December 31, 2024; and <u>expended</u> by December 31, 2026.** Any funds not spent must be returned to the U.S. Treasury.

Most Vermont municipalities solicited ideas from community members on how to use their one-time monies. Wheelock's volunteer ARPA Committee, appointed by the Selectboard, suspended activity after meeting three times in 2022, when the Selectboard voted to use "*a majority of ARPA funds for the Town Hall accessibility project, with the excess funds to be used for other projects recommended by the ARPA Committee, with the approval of the Selectboard.*" (5/3/22 SB meeting)

So far, ARPA monies, totaling \$116,907, have been used for a variety of expenses. None are related to the Town Hall accessibility goal. The payments are outlined in the **Town Report** (pages, 13, 14, 16):

2021 - \$999 IT 2022 - \$17,112 Town Garage repairs

2023 - \$98,796 Roads, sheriff patrol, IT, fire safety, property maps.

As of this writing, the Selectboard has decided to move the remaining funds (\$130,065) "to the general fund" (*Minutes of Jan. 30, 2024*).

# **FEMA Followup**



The Town Report outlines extraordinary town highway expenses from 2023 and in the proposed 2024 budget. FEMA reimbursements for road repairs

from the summer's flood damage may not cover as much of the expenses as anticipated. The Selectboard continues to work with FEMA officials to determine which costs are eligible for reimbursement.
