Selectboard News and Notes

he Selectboard considered the Vermont Legislature's decisions governing how 2022 town meetings may be held. Legislators approved modifications similar to those enacted in 2021. Under S. 172, towns are allowed to hold votes via Australian ballot or to postpone inperson meetings until warmer weather allows for

outdoor gatherings. In addition, *S.223*, states filing petitions containing voters signatures are not required for candidates for local office. At their Jan. 18th meeting, Selectboard members voted to conduct **Town**Meeting by Australian Ballot, so all articles on the warning, including electing Town Officers, will be by Australian Ballot.

Polls will be open at Town Hall, Tues., Mar. 1, from 10:00 am - 7:00 pm. A remote informational meeting will be held Fri., Feb. 25 at 6:00 pm. February's *The Miller's Run* newsletter will have more details about the informational meeting and Town Meeting.

Wheelock ARPA Committee



Wheelock's American Rescue Plan Act (ARPA) appropriation (\$246,912.91) must be committed no later than 12/31/24 and expended

no later than 12/31/26. Any funds not spent must be returned to the U.S. Treasury, which urges State and local governments "to engage their constituents and communities in developing plans" to use these funds. The Vermont League of Cities and Towns and other development groups are offering guidance to help citizen advisory committees work within the complex federal regulations. The Wheelock Selectboard has formed an advisory ARPA Committee and welcomes citizen participation to help research and determine the best use for these funds. Contact the Town Clerk's office if you would like to participate.

Vermont Supreme Court Act 250 Decision

A recent decision by the court interprets Act 250 (Vermont's land use law) differently from how it's historically been applied. It would make it easier for commercial/industrial developers to construct projects in towns with weak or no existing land use regulations. In the Northeast Kingdom, 78% * of municipalities have only minimal or no zoning or subdivision regulations (Wheelock has none). Under this new interpretation, Act 250 would be triggered only if a developer used or "physically disturbed" an acre or more. The ruling by the five justices was unanimous. The court has reopened the decision for re-argument, however, and four parties are opposing the decision.

Wheelock Town Hall Accessibility Project

At the 2022 Town Meeting the Selectboard is asking Wheelock voters to choose between the two options to address our Town Hall's lack of accessibility. The Town Meeting Warning will have two articles, each asking voters to vote YES or NO on their preference for the two design options.

This vote will help the Selectboard determine which option to further develop with additional design work and construction bid documents. Voters will receive a mailer to their homes about the options in advance of Town Meeting. It outlines design features, cost estimates, projected municipal loan costs, and property tax effects.
